Client Agreement

BNG and/or affiliates (hereinafter referred to as ""BNG"") is a management company. While we feel that you are more likely to obtain such credit if your company is in corporate compliance (office listing, telephone 411 listing, website, ect...) the ultimate credit decision remains with the bank, lender or credit grantor, and we cannot control that process in any way.

Client agrees to provide "BNG" necessary personal & business information as required by us to complete the transition of our corporation to you, and further agrees to execute the limited Power of Attorney (see below). Client waives his or her right to privacy of the information provided and empowers "BNG" to correspond directly with Dunn & Bradstreet (D&B) or Business Equifax or Experian Business.

Client further gives and grants "BNG" full power and authority to do and perform every act necessary and proper in the exercise of any of the powers granted hereunder as fully as Client might or would do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that said attorney in fact shall lawfully do or cause to be done by virtue of hereof. I agree that any third party who receives a copy of this document may act under it. Revocation of the power of attorney is not effective as to a third party until the third party has actual knowledge of the revocation. I agree to indemnify the third party for any claims that arise against the third party because of reliance on this power of attorney.

You hereby consent to the exclusive jurisdiction and venue of the courts in Roseville, California, USA in all disputes arising out of or relating to this agreement. Any dispute arising hereunder shall be resolved by binding arbitration in Roseville, California under the American Arbitration commercial arbitration rules. Any liability of "BNG" hereunder shall be limited to the actual fees and charges paid by Client. If any part of this agreement is determined to be invalid or unenforceable pursuant to applicable law, the remainder of this agreement shall continue in effect. Notwithstanding any other provision in this or any other agreement between the parties, the provisions of this agreement shall prevail in the event of any conflict, and all nonconflicting terms and conditions contained in any other such agreement are incorporated herein by reference. In the event "BNG" engages in collection efforts, you shall be required to reimburse "BNG" for it's out of pocket costs per any such collection efforts, including the fees and charges of a collection agent, which shall be deemed to be 40% of the outstanding unpaid balance of the defaulted account.
